Edwards Aquifer Authority

Minority and Women-Owned Business Enterprise Program

I. POLICY

It is Edwards Aquifer Authority's (EAA) policy that minority and women-owned business enterprises (M/WBEs) have equal opportunity to participate in the performance of EAA contracts and subcontracts. The EAA shall make a good faith effort to award contracts to minority-owned and women-owned businesses in the amount of 30 percent of the total amount (value) of those contracts. A minority and women-owned business program has been adopted to foster M/WBE participation in EAA contracting and subcontracting activities.

a. Applicability

The Minority and Women-Owned Business Policy is governed by the Edwards Aquifer EAA Bylaws, as adopted.

b. Objectives

- i. To ensure nondiscrimination in the award and administration of EAA-related contracts and procurements to all bidders, proposers, and vendors and by EAA contractors, subcontractors, consultants, and sub-consultants.
- ii. To promote efforts, approaches, and initiatives that will foster more effective participation by minority and women-owned businesses and enhance their competitiveness and qualifications, thus affording a full and fair opportunity to compete on the EAA's contracting and procurement opportunities.
- iii. To more effectively promote the EAA's business opportunities to minority and women-owned firms.
- iv. To remove barriers to the participation of minority and women-owned firms in EAA contracts through implementation of mechanisms that facilitate contractor teaming, subcontracting and joint venture relationships.

c. Administration of Program

The General Manager of EAA is responsible for ensuring all EAA personnel adhere to the provisions and spirit of the M/WBE program. The General Manager has delegated responsibility for the development, implementation, and monitoring of this program to the EAA M/WBE Coordinator. The M/WBE Coordinator shall assist EAA staff to identify M/WBEs to submit bids or proposals and provide information to contractors seeking M/WBE subcontractors.

d. Equal [Employment] Opportunity

The EAA does not exclude persons from participation in, deny benefits to, or otherwise discriminate against any persons in connections with the award and performance of any contract governed by the Edwards Aquifer Act on the basis of race, color, sex, sexual orientation or national origin.

The EAA also prohibits a contractor performing under an EAA agreement to discriminate on the fact or perception of a person's race, color, sex, sexual orientation or national origin with respect to employment, sub-contracting or sub-consulting opportunities.

The EAA further encourages contractors to, the furthest extent feasible, provide employment opportunities to <u>underrepresented</u> minorities [African Americans, Hispanic Americans, and American Indians] in Science, Technology, Engineering, and Mathematics (STEM) industries.

II. PROCUREMENT

The EAA's Procurement Policies and Procedures describe how the EAA purchases goods and services in accordance with applicable state and local statutes. These Procurement Policies and Procedures are the means by which the EAA implements this M/WBE program. The following describes how the M/WBE program applies to the EAA's procurement activities.

Just as the EAA shall make a good faith effort to award contracts to M/WBE firms, potential contractors ("bidders" or "proposers") shall also make a good faith effort to take all necessary and reasonable steps to ensure that M/WBEs have equal opportunity to participate as subcontractors. Failure by a contractor or subcontractor to carry out good faith efforts may constitute a breach of contract and, after notification of such breach by the EAA, may result in termination of the contract. The EAA reserves the right to request a written commitment from the proposer to use good faith efforts to provide equal employment opportunities during the term of the contract. The EAA may also require the proposer to provide EAA with relevant employment data of its workforce.

To be an eligible M/WBE under this program, contractors and subcontractors must be certified as a minority business enterprise or women business enterprise MBE or WBE by a recognized governmental program, such as the South Central Texas Regional Certification Agency (SCTRCA).

At the EAA's discretion, disadvantaged business enterprise ("DBE") or historically underutilized business ("HUB") certification may be accepted from firms determined

to be owned and controlled by minority or women individuals by a recognized governmental program, such as:

- Texas Unified Certification Program; or
- State of Texas Historically Underutilized Business (HUB) program.

Any entity identified as an M/WBE, DBE, or HUB (as either a prime or subcontractor) shall submit a copy of its certification with its proposal. The EAA reserves the right to verify any entity's certification status prior to contract award.

III. SOLICITATIONS

- a. The EAA will review any proposed contract with an estimated value of \$50,000 or more to determine if subcontract opportunities are probable prior to the EAA's solicitation of bids, proposals, offers or other applicable expressions of interests.
- b. If the EAA determines subcontract opportunities exist for a contract, a *Probable Subcontracting Opportunities* form outlining the anticipated line items for subcontracting will be included in the solicitation. (See Exhibit A)

IV. SUBCONTRACTING PLANS

- a. The EAA strongly encourages the prime contractor/consultant to provide subcontracting opportunities for all firms and make every good faith effort to solicit M/WBEs to perform meaningful work in all aspects on projects with an estimated value of \$50,000 or more.
- b. If the EAA determines that subcontract opportunities exist, completion of a *Project Subcontracting Plan* and all applicable sections will be required in order to be deemed responsive at the discretion of the EAA. (See Schedule A)

V. PROPOSAL EVALUATION AND AWARD

- a. Good Faith Efforts
 - Proposers should review directories of certified firms from the South Central Texas Regional Certification Agency Directory and/or the State of Texas centralized master bidders list (CMBL) by categories consistent with anticipated subcontracting opportunities.
 - ii. Proposers should solicit the interest of certified firms and allow sufficient time for potential subcontractors to respond to the solicitation. Proposer should solicit through all reasonable and available means, including mailing, emailing, and faxing information on subcontracting opportunities to all or some firms on the certified lists and to all other interested firms,

- advertising in local, small/minority/women-owned business focused newspapers (where available), and attendance at pre-proposal meetings.
- iii. Proposer should provide interested firms with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.
- iv. Proposer should document in writing all M/WBEs solicited in the *Project Subcontracting Plan* form for projects exceeding \$50,000, as requested. (See Schedule A)
- v. Proposals should break out contract work items into economically feasible units and, where possible, identify rotation of work opportunities so that firms may participate as subcontractors.
- vi. Proposers should work within their own resources to determine the qualifications of any potential M/WBE subcontractor and should not reject M/WBEs as unqualified without a thorough investigation of their capabilities.
- vii. Proposer should follow up with all competitive bids/proposals from M/WBE firms to clarify any questions that may arise. If M/WBE proposals or quotes are not utilized in the identified areas of work, the proposer should document in writing the reasons for this decision, and submit the documentation when responding to an EAA solicitation.
- viii. Proposer should use the services of available minority/women community organizations; minority/women contractors' groups; local, state, and Federal minority/women business assistance offices, HUB/M/W/DBE directories; and other organizations and resources to provide assistance in the recruitment and placement of firms. (See Attachment A)

b. Recommendation for Award

i. Staff evaluation of proposals/bids

The EAA will review all the facts in the record to determine if the respondent made adequate good faith efforts to notify and include M/WBEs as subcontractors on the project. While the absence of subcontractor and/or M/WBE participation is <u>NOT</u> an automatic disqualification, the EAA may deem an incomplete *Project Subcontracting Plan* as a non-responsive proposal and not consider the respondent for award.

VI. POST AWARD RESPONSIBILITIES

a. Record Retention

i. Contractor must maintain (and make available upon request) records of all subcontracts entered into with firms and records of materials purchased from suppliers on EAA projects. Such records shall show the name and business address of each subcontractor or vendor and the total dollar amount actually paid to each subcontractor or vendor.

b. Reporting

- i. The respondent must submit regular *Subcontractor Utilization Reports* to the EAA (or its designated contracting agency) with the contractor's billing, which includes the use of and expenditures made to its subcontractors (both M/WBEs and Non-M/WBEs). (See Schedule B)
- ii. The utilization of M/WBE lawyers at non-M/WBE law firms will be requested monthly through completion of a *Legal Services Invoice Report*. The report will indicate the extent to which non-M/WBE law firms, retained by the EAA, assign M/WBE lawyers to work on EAA related projects. (See Schedule C)

VII. DEFINITIONS

- a. Business, business concern or business enterprise means an entity organized for profit with a place of business located in the United States, and which operates primarily within the United States or which makes a significant contribution to the United States economy through payment of taxes or use of American products, materials, or labor.
- b. *Contract* means a legally binding relationship obligating a seller to furnish supplies or services (including, but not limited to, construction and professional services) and the buyer to pay for them.
- c. *Contractor* means one who participates, through a contract or subcontract (at any tier), on an EAA assisted contract.
- d. *Disadvantaged business enterprise* ("DBE") means a for-profit small business concern—
 - (1) That is at least 51 percent owned by one or more individuals who are both socially and economically disadvantaged or, in the case of a corporation, in which 51 percent of the stock is owned by one or more such individuals; and
 - (2) Whose management and daily business operations are controlled by one or more of the socially and economically disadvantaged individuals who owns the firm.

(Exception: the EAA will only count participation from DBE firms determined to be owned and controlled by minority or women individuals by a recognized program.)

- e. *Good faith efforts* means efforts to achieve a goal or other requirement of this part which, by their scope, intensity, and appropriateness to the objective, can reasonably be expected to fulfill the program requirement.
- f. Historically underutilized business ("HUB") means a for-profit business concern—
 - (1) That is at least 51 percent owned by one or more minority, woman or service disabled veteran individuals, who reside in Texas and actively participate in the control, operations and management of the entity's affairs; and
 - (2) Has not exceeded the size standards prescribed by 34 TAC §20.23; and
 - (3) Has its principal place of business in Texas.
 - (Exception: the EAA will only count participation from HUB firms determined to be owned and controlled by <u>minority or women individuals</u> by a recognized program.)
- g. *Minority-owned business enterprise* ("MBE") means a for-profit business concern—
 - (1) That is at least 51 percent owned by one or more minority individuals, in the case of a corporation, in which 51 percent of the stock is owned by one or more such individuals; and
 - (2) Whose management and daily business operations are controlled by one or more of the minority individuals who owns the firm.

Minority group members as defined by the SCTRCA Policy and Procedures Manual may include:

- a. African Americans;
- b. Hispanic Americans;
- c. Asian-Pacific Americans;
- d. Asian-Indian American; or
- e. Native Americans.
- h. *Joint venture* means an association of a M/W/DBE firm and one or more other firms to carry out a single, for-profit business enterprise, for which the parties combine their property, capital, efforts, skills and knowledge, and in which the M/W/DBE is responsible for a distinct, clearly defined portion of the work of the contract and whose share in the capital contribution, control, management, risks, and profits of the joint venture are commensurate with its ownership interest.
- i. South Central Texas Regional Certification Agency ("SCTRCA") means a 501 (c) (3) non-profit corporation that represents several public entities in the South Texas area. These entities are committed to enhancing participation for disadvantaged, small, minority and woman owned businesses in public/government contracting and purchasing activities.

- j. Texas Unified Certification Program means a group of agencies organized through requirements of 49 CFR Part 26 to conduct DBE certification services. These agencies include Texas Department of Transportation, North Central Texas Regional Certification Agency, South Central Texas Regional Certification Agency, City of Austin, Corpus Christi Regional Transportation Authority, and City of Houston.
- k. Women-owned business enterprise ("WBE") means a for-profit business concern—
 (1) That is at least 51 percent owned by one or more women individuals, in the case of a corporation, in which 51 percent of the stock is owned by one or more such individuals; and
 - (2) Whose management and daily business operations are controlled by one or more of the women individuals who owns the firm.
