## Application for Well Capping Permit

### One application required for each well.

1. This application must be completed, signed, and submitted to the EAA prior to capping an Edwards Aquifer well.
2. The application must be typed or printed legibly using ink.
3. A fee of \$125.00 must accompany the application. (\$25 application fee and \$100 administrative fee)
4. Checks and money orders made payable to the "Edwards Aquifer Authority" will be accepted. Do not submit cash. To pay by Credit Card, please open <https://www.edwardsaquifer.org> and click Online Payments and follow the instructions. **Please provide the payment Confirmation No.** \_\_\_\_\_.
5. Upon receipt of a complete application, please allow thirty (30) days for processing.
6. Incomplete applications will be returned to the applicant for completion.
7. Well capping cannot commence until the application is approved and a well capping permit has been issued.
